#### **CALL FOR PAPERS**

- **Seeing Things Differently: Art, Philosophy, and the Futures of Feminism (Dundee, Scotland)**

**Date:** Friday 30 and Saturday 31 March, 2012

**Location:** University of Dundee, Scotland

**Subject:** The visual arts have a well-established history of engagement with feminism and gender issues. While artists have confronted such issues directly in their work, feminist theorists and philosophers have interrogated the gendering of vision as well as core aesthetic categories such as genius and the art/craft distinction. The 'feminist' label, however, can sometimes seem more of a trap than a call for liberatory practices. This event takes as a starting point the idea that neither all artworks nor all theories informed by a gendered or feminist perspective will necessarily be focused on what we might think of as 'questions of gender' or 'women's issues'.

**Keynote Speakers:** Dr. Christine Battersby (University of Warwick), Prof. Tina Chanter (DePaul University, Chicago), Prof. Kerstin Mey (University for the Creative Arts)

- **Digital Crossroads: Media, Migration and Diaspora in a Transnational Perspective (Utrecht University, NL)**

**Subject:** The rapid development of digital technologies has radically transformed ways of keeping in touch with home cultures and diasporic networks. The aim of this conference is to address the relationship between migration and digital technologies across national contexts and ethnic belonging. The conference will explore three inter-related strands of the relationships between media and migration: *Identity and diaspora* (Strand 1), *Migrant networks* (Strand 2), and *Learning in a globalized world* (Strand 3).

- **The Multiple Life Cycles of Children's Media: Childhood Nostalgia in Contemporary Convergence Culture (University of Reading, UK)**

**Date:** Friday August 31 and Saturday September 1, 2012

**Location:** University of Reading, Centre for International Research in Childhood (CIRCL), Reading, UK

**Subject:** Nostalgia has shaped the cultural construction of childhood ever since Romanticism, but it seems to have undergone a significant change in the late twentieth century. Nowadays, childhood is no longer exclusively associated with a pre-lapsarian state of nature that we are irrevocably cut off from as we are socialized into language and culture. Rather than the lost paradise it once was, childhood is increasingly identified with the toys, games, and media products of one's youth. Through shared practices of

cultural remembrance these commodities are imbued with new symbolic significance. This shift implies that our childhood is not as lost anymore as it used to be within the Romantic paradigm. Not only do the commodities of childhood remain accessible as collectors' items, but commercial companies also stimulate the nostalgia for childhood by reissuing the books, comic strips, radio and TV programmes, music recordings, films, and toys that used to be sold to previous generations of children and adolescents. This is not just done with a view to attracting new generations of consumers, but also to cater to adults (second-time consumers) who want to recapture the experiences of their youth. This international PLACIM workshop wants to analyze and evaluate the renegotiation of childhood nostalgia in contemporary convergence culture.

**Subject:** Renske Vrolijk, the initiator of this program, creates in two unconnected parts a portrait of two female aviation pioneers: Amelia Earhart and Hanna Reitsch with three other contemporary composers. The musical theater piece of composer Lucas Wiegerink is a tribute to Emmeline Pankhurst (1858-1928), who successfully fought for women's suffrage in Britain. Composer Michael Mensingh, with one foot in pop music and with the

other in contemporary composed music, was inspired by Rosie the Riveter. Rosie was the figurehead for the approximately six million women during World War II, who occupied the place in the factories of the men who fought at the front. Philosopher and writer Gertrude Stein (1874-1946) was the inspiration for the American composer Vanessa Lann.

• **Conference: 'Transforming Gender Orders: Intersections of Care, Family and Migration' (Goethe University, Germany)**

**Date:** Wednesday January 18, Thursday January 19, Friday January 20, 2012

**Location:** Campus Westend, Casino, Room 1.801; Grüneburgplatz 1; Frankfurt am Main

**Subject:** This conference takes up the controversies about the transformation of gender relations in the course of globalization processes and strives for a discussion from new perspectives. Drawing on the work of R. Connell gender orders refer to historically constructed patterns of power relations between men and women (not only as subjects, but also in the social arrangements of masculinity and femininity) which are mediated and institutionalized via distinctions and relations. We seek to analyze both the normative and symbolic aspects of these relations and the social and cultural codings and the spaces of action of relations between the genders and within one of the gender groups. This conference investigates the transformation of gender orders in transnational space. We are concerned with social, political, economic, and cultural relations and forms of integration, which traverse the borders of nation states.

• **Institute for World Literature (Istanbul, Turkey)**

**Date:** Monday June 25, 2011 – Thursday July 20, 2012

**Location:** Bilgi University, Istanbul

**Subject:** The study of world literature has expanded in recent years into a far-reaching inquiry into the variety of the world's literary cultures past and present. Courses in world literature are gaining new prominence around the world, and conferences on world literature are attracting large numbers of scholars in many countries engaged with an increasingly global literary world, from China to Turkey to Brazil. These developments

open up exciting new possibilities for studying the world's literatures – including the European literatures themselves – and yet relatively few colleges and universities are presently equipped to train people to teach beyond the purview of a single nation or a regional cluster of countries. The Institute for World Literature has been established to meet this need. Overseen by an international board of advisers and directed by David Damrosch of Harvard University, the Institute meets for four weeks each summer, giving faculty and graduate students the opportunity to come together to explore the theory and practice of teaching and studying world literature. The Institute features a mixture of intensive two-week seminars and guest lectures given by leading theorists and practitioners of world literary study, together with sharing of work among the participants themselves.

#### • **PhD vacature 'Spektakels van Burgerschap (Universiteit van Amsterdam, NL – Dutch only)**

**Beschrijving:** In het project 'Spektakels van burgerschap: de tentoonstelling als politiek repertoirestuk van het Nederlandse feminisme in de lange twintigste eeuw' wordt onderzocht met welke bewegredenen, op welke manier en met welk politiek effect door

Nederlandse feministen in de loop van de lange twintigste eeuw (1890-heden) telkens weer gekozen is voor een vorm van tentoonstellen om de eigen politieke doelstellingen uit te dragen. Het gaat daarbij in de eerste plaats om vier nationale evenementen, de Nationale Tentoonstelling van Vrouwenarbeid in 1898, de tentoonstelling De Vrouw 1813-1913, de tentoonstelling De Nederlandse vrouw 1898-1948 en de tentoonstelling Emancipade uit het Internationale Jaar van de Vrouw 1975. Na 1975 is er sprake van een aantal kleinere tentoonstellingen die zich ook steeds meer in een digitale, virtuele omgeving afspelen, vaak georganiseerd door erfgoed-instellingen als IIAV/Aletta of Imagine IC, soms ook door individuele activisten. Een en ander kan in dit onderzoek worden gecontextualiseerd door vergelijking met relevante politieke repertoires in Nederland en/of andere nationale omgevingen. Kandidaten worden uitgenodigd tot het inleveren van een uitgewerkt onderzoeksvoorstel.

• **Tijdschrift voor Genderstudies 2011-4: 'Opvoeding en onderwijs als genderfabriek?' (Dutch only)**

**Thema:** De laatste jaren worden we in de media overspoeld met berichten over onderzoek waaruit zou blijken dat meisjes en jongetjes neurologisch wezenlijk verschillend zijn: zowel in de manier waarop hun hersenen zijn opgebouwd als waarop deze functioneren. Aan die bevindingen wordt dan de conclusie verbonden dat sekseverschillen "dus" aangeboren zijn en dat we daarmee maar beter rekening kunnen houden in opvoeding, onderwijs en inrichting van de maatschappij. Een ander belangrijk inzicht uit de neurologische wetenschappen blijft echter buiten beschouwing, namelijk dat het brein zich onder invloed van de omstandigheden in uiteenlopende richtingen kan ontwikkelen. Hierom moeten we ons de vraag blijven stellen welke sekseverschillen zich in de praktijk voordoen, op welke wijze opvoedings- en onderwijs situaties daarvan bijdragen en wat de relevantie ervan is. Dit themanummer van het Tijdschrift voor Genderstudies gaat dan ook over de ontwikkeling van meisjes en jongens in de context van gezin en school.

**Contributies onder andere:** **Van Rooij** informeert ons over verschillen in genderidentiteitsontwikkeling tussen kinderen uit Nederlandse twee-moeder en vader-moeder gezinnen. **Brouckaert** documenteert een andere vorm van non-normatief ouderschap door te beschrijven hoe Vlaamse en Franse 'moeders zonder papieren' (verblijfsvergunning) uit internationale (gender) praktijken putten voor de opvoeding van hun kinderen tot burgerschap. **Van de Weerd en Rommes** laten zien dat Nederlandse meisjes weliswaar minder zelfvertrouwen en een negatievere attitude hebben ten opzichte van bétavakken - vermoedelijk onder invloed van de culturele stereotypen - maar maken ook aannemelijk dat docenten die negatieve spiraal kunnen doorbreken met goede uitleg, enthousiasme, het uitdelen van complimenten en ander sociaal gedrag. **Harthoorn en Kraus** laten in hun opiniebijdrage zien dat mannen tegenwoordig worden aangezet tot actief vaderschap vanwege hun *wezenlijke* andere inbreng dankzij *het evolutionaire verschil met vrouwen* -waarmee we weer terug lijken te keren naar de jaren zestig van de vorige eeuw.

- **'Deconstructing Europe. Postcolonial Perspectives' by dr. Sandra Ponzanesi and dr. Bolette Blaagaard**

**Subject:** This book engages with the question of what makes Europe postcolonial and how memory, whiteness and religion figure in representations and manifestations of European 'identity' and self-perception. To deconstruct Europe is necessary as its definition is now contested more than ever, both internally (through the proliferation of ethnic, religious, regional differences) and externally (Europe expanding its boundaries but closing its borders). This edited volume explores a number of theoretical discussions on the meaning of Europe and proposes analyzing some of the deeds committed, both today and in the past, in the name of Europe by foregrounding a postcolonial approach. The chapters deal with social and political formations as well as cultural and artistic practices drawing from different disciplinary backgrounds and methodological traditions. The objective of this volume is to account for historical legacies which have been denied, forgotten or silenced, such as the histories of minor and peripheral colonialisms (Nordic colonialisms or Austrian, Spanish and Italian colonialism) and to account for the realities of geographical margins within Europe, such as the Mediterranean and the Eastern border while tracing alternative models for solidarity and conviviality. As such it creates an innovative space for comparative and cross-disciplinary exchanges.
