• InterGender PhD course 'Carnal Aesthetics: Challenging the Visual in Feminist Analysis' (Utrecht University, NL)

Location: Utrecht University, the Netherlands

Course description: This PhD course is organized by the Netherlands Research School of Gender Studies (NOG) at Utrecht University and InterGender (Swedish-International

Research School in Interdisciplinary Gender Studies). Art today is an increasingly multifaceted phenomenon, encompassing challenging works that intervene in war and ecological disasters, in inequalities and revolutionary changes in technology. Employing recent theories of transgressive body imagery, trauma, affectivity and sensation, this course will analyze a wide range of case studies from contemporary visual culture. It will provide a novel approach to art and culture by challenging the primacy of vision and by injecting an intersectional perspective into the fields of visual culture, contemporary art theory, film and media studies as well as trauma studies. It will appeal to PhD students across these dynamic fields of exploration who deal with the socio-political nature of contemporary visual culture in their research.

Structure of the course: The course consists of three days of lectures and seminars. Students will be asked to have completed the course readings (distributed digitally) before the beginning of the course. The course will also include an evening trip to an exhibition/art performance/theatre performance (specified close to date). To obtain credits, a 15-pages essay is required.

• 2 EU Marie Curie PhD positions in the field of Transdisciplinary Diaspora Studies (Westfälische Wilhelms-Universität Münster, Germany)

Description: The university offers 2 Marie Curie PhD positions in the project 'Literary Refractions of Migration Laws in Post-Colonial Novels'. This project undertakes to examine, by the example of select works of contemporary post-colonial literature, representations of the impact of legal systems on migration and constructions of home and belonging in the diaspora. Drawing on legal theory and cultural studies, the focus will be on legal questions involving diasporic communities, especially processes of assimilation and integration and their representation in law and in literature. Applicants will be expected to engage in a continuing dialogue about the methodology, theory, and terminology of diaspora studies as a transdiscipline. In the context of the specific project, this entails literary/cultural studies, law, and post-colonial studies.

Criteria: Students must have a first class Master's degree (or equivalent) in one of the following areas: literary studies, law, postcolonial studies. More criteria can be found on the website below.

• 2 PhD positions on 'Diasporas and Contested Sovereignty' (University of Amsterdam, NL)

Description: A team of four researchers will investigate the transnational mobilization of conflict-generated diasporas in Europe and their impact on polities experiencing contested sovereignty in the Balkans, the Caucasus, and the Middle East. The team aspires to answer an overarching question: does the mobilization of conflict-generated diasporas in liberal states have a mitigating or exacerbating effect on political conflict in the original homelands? The overall project focuses on five levels of analysis: 1) the attitudes of elite and non-elite individuals, 2) characteristics of specific groups, 3) five nation-states with different migrant incorporation regimes (France, Germany, the Netherlands, Sweden, and the UK), 4) diaspora linkages to supranational EU and global institutions, and 5) diaspora mobilization patterns specific to each of the three conflict-prone regions. The starting date is September 1, 2012.

Criteria: Candidates with academic background in comparative politics, international relations, transnationalism, migration, foreign policy analysis, or other relevant post-graduate experience are encouraged to apply. One PhD researcher will focus on the Bosnian diaspora mobilization in selected EU countries for the post-conflict reconstruction process in Bosnia-Herzegovina. The other PhD researcher will focus on the Iraqi diaspora in Europe and Iraq. Linguistic skills are required:

Bosnian/Serbian/Croatian - for PhD researcher 1, and Arabic for PhD researcher 2. Researchers will be expected to do multi-sited research both in Europe and Bosnia-Herzegovina/Iraq, assist with the organization of project-related events, attend courses within the PhD program, write a dissertation and other publications, and teach in the field of political science.

• 3 PhD positions on 'Performance and (neo-) burlesque corporality' (Maastricht University, NL)

Description: The Graduate School of the Faculty of Arts and Social Sciences of Maastricht University offers 3 PhD positions (3 or 4 years). Supervising Team: Prof. Dr. M. Meijer (supervisor), Dr. K. Vanhaesebrouck (co-supervisor).

The performance genre of neo-burlesque has gained increasing interest over the last two decades, gradually mutating from a joyful but subversive underground culture in which the possibilities of the female (and sometimes male) body as a tool both for radical critique and bawdy humour are investigated, to mainstream culture. Through its pronounced taste for surprise, double entendre, wonder and extravaganza, burlesque performance entailed both social and interpersonal critique, exposing the bodily fantasies lingering behind late 19th and 20th century Western culture. This PhD-project aims at analysing the different representational and performative strategies at work in contemporary neo-burlesque performance practices, while, at the same time, comparing these practices to their historical antecedents and re-investigating Judith Butler's conceptual apparatus on the performativity of gender representations.

• PhD position on 'Narrative Strategies for the Kinning of Foreigners in Global Adoption, 1950-2010' (Maastricht University, NL)

Description: Becoming a parent through global adoption (GA) does not only entail legal procedures, but also cultural work. During their 2-3 year 'pregnancies', adopters refashion their individual identities and those of their children-to-be into familial identities, a process that is continued long after the arrival of the adoptee. Narrative plays a crucial role in these ongoing processes of identity renegotiation. In late modernity, individual identity is primarily experienced as a life story that we work on from early adolescence onwards. The ability to craft a coherent and persuasive life story is essential to gaining social recognition in Western (neo-)liberal societies. Hence, adopters take frequent recourse to life writing to enact their new-fangled parenthood on different media platforms. Considerable narrative efforts are also invested in the weaving of origin stories for infant adoptees who cannot as yet craft their own life stories, as becomes manifest in the numerous autobiographical writings by adopters that target adoptees and in the flourishing niche market of children's books about GA. Finally, the Korean adoption experience has revealed that adult adoptees often 'write back' to the stories imposed upon them in their youth by telling their life stories in their own voice. Naturally, the narratives of stakeholders do not develop in a social vacuum, but in response to wider debates in the popular press and to stories about global adoption in popular media, especially films and documentaries. We invite PhD project proposals that analyze the narrative "kinning" (cf. Signe Howell, The Kinning of Foreigners: Transnational Adoption in a Global Perspective, 2006) of foreigners through life writing

and narrative fiction, focusing on European receiving countries. Supervising team: Dr. E. Wesseling, Prof.dr. M. Meijer.

Criteria: Students with a degree in Literary Studies, Cultural Analysis, Media Studies or Cultural Anthropology may apply to this project.

PhD Thesis: 'Haunted by Reality. Toward a Feminist Study of Documentary Film:

Indexicality, Vision and the Artifice'.

Subject: Through the lenses of cultural studies, semiotics, gender studies, film theory and visual anthropology, this dissertation contributes to bringing back documentary film into the arena of feminist intervention. Documentary films are here considered as an exemplary site that allows tackling issues of reality and representation, subjectivity and power, the specificities of audio-visual technologies and their implications in the construction of the Other. Exploring the interconnections between the politics and the aesthetics of documentary, this study emphasizes what these films can do, highlights the links between documentary practices and the processes of knowledge production and, finally, points the attention to the critical and transformative promise that resides in the encounters between feminism and documentary.
