# RMA Gender and Ethnicity highest ranking in CHIO Keuzegids Masters 2013 (Utrecht University, NL)

### Doing Gender Lecture Susan Stryker: May 30 (Utrecht University, NL)

In the spring of 2013 the Netherlands Research School of Gender Studies (NOG) in cooperation with Graduate Gender Programme (GGeP) at Utrecht University organises a tenth round of the series of lectures entitled Doing Gender. On May 30 Susan Stryker will give a Doing Gender Lecture. Susan Stryker is Associate Professor of Gender and Women's Studies and Director of the Institute for LGBT Studies at the University of Arizona. Stryker will use the career of the 1950s transsexual icon Christine Jorgensen to explore identity, embodiment, technology and representation. Eliza Steinbock (Centre for Gender and Diversity, Maastricht University) will give a response. Stryker's Doing Genderlecture, entitled 'Christine in the Cutting Room' will be held from 14-16hrs at Utrecht and is free and open to the public. Note: registration by email is necessary.

### Colonial Legacy Conference: 'Treaty of Utrecht: 1713 – 1863 – 2013' (Utrecht University, NL)

The Centre for the Humanities (Utrecht University) is organising 'The Colonial Legacy' conference from 21-22 June 2013. This conference links the commemoration of the Treaty of Utrecht in 1713, to the abolition of Slavery by the Dutch in 1863. Over the course of two days, distinguished academics such as Paul Gilroy, Achille Mbembe and Catherine Hall will delve into the legacy of the Treaty of Utrecht, the history of slavery, the state of slavery today and the connections between

them. The conference will take you from history and philosophy, to anthropology and post-colonialism, transnational memories and transitional justice. In a great number of interdisciplinary lectures and panels, scholars will examine the lasting legacy of slavery and the persistent presence of human trafficking in the contemporary world. Speaker include: prof. Rosi Braidotti, dr. Philomena Essed, prof. Halleh Ghorashi, dr. Françoise Vergès, prof. Gert Oostindie, prof. Kevin Bales, prof. Michael Rothberg, dr. Rutvica Andrijasevic.

# Summer School 'Slavery: The Past and Present of Social (Un)Justice. Introducing the Decolonial Option' (University College Roosevelt, Middelburg, NL)

The 4th edition of the Middelburg Decolonial Summer School focuses on 'Slavery: The Past and Present of Social (Un) Justice' and is designed to investigate the logic and presupposition of Global Un-Justice in the modern/colonial world, from 1500 to 2000. There will be payed special attention to emerging projects, parallel to the decoloniality option, who are working toward overcoming the legacies of the Colonial difference and more generally the South-North devide. If un-justice operate at all levels of the socio-economic and cultural spectrum, from economy to politics, from religion to aesthetics, from gender and sexuality to ethnicity and racism, and above all, in the control of knowledge, the decolonial task, that of overcoming coloniality requires the participation of many people in many areas of knowing and doing. Activists, artists, scholars, jounalists will, among others, contribute to the goals of the 4th edition of the Decolonial Summer School in Middelburg.

# Summer School 'Language, gender, and sexuality: Discourses of precarious citizenship in precarious times - the Balkan experience' (Lesvos island, GRC)

LAGESEC 2013 is an interdisciplinary summer school focusing on language, gender, and sexuality and its implications for citizenship in the geopolitical area of the Balkans. It brings together scolars from a variety of fields in the humanities and the dsocial sciences in an attempt to enhance dialogue among researchers in liguistics, anthropology, gender/sexuality studies, and Balkan studies. The major goal is to familiarize students with the fact that the national narratives produced in the Balkans (and elsewhere) are simultaneously gendered, sexed, and ethnic as well as linguistic. It is the indexial relations holding between these which inform LAGESEC 2013.

### **COST Grants for Short Term Research Visits and PhD Summer Schools**

COST Network The Dynamics of Virtual Work offers opportunities to publish, to present ongoing research and to network trough general activities of the Working Groups and by organizing specific events and grant opportunities. The Netherlands is part of this network through the Institute for Gender Studies, Radboud University Nijmegen and Amsterdam University. Grants are available for short term visits and summer schools.

Limited numbers of funded places are still available for PhD and Post-doctoral researchers to attend Summer Schools on Virtual Work this year, funded by COST (European Cooperation in Science and Technology). These will be held in Bulgaria, July 22-26 and in Malta, September 16-20.

A short-term scientific mission is a visit from an ESR based in one COST participating country to an institute in another COST participating country. This could be to work on a jointly authored article, to carry out fieldwork, to learn a new research method, to work on a joint research proposal or any other activity linked to your research on the dynamics of virtual work.

Libraries are strange places: they bear the promise of unlimited access to the truth, but also appear as impenetrable labyrinths where the truth always seems to be just out of reach. At least, that is how libraries are commonly imagined throughout western literature and popular culture. However, paradoxically, new digital technologies simultaneously seem to reawaken the dream of a universal library. The simultaneous fantasy and fear of the library, as I argue in my dissertation, is intertwined with modern rationality: its aspirations, its discontents, and its gender politics.
