#### Postcolonial Film and Lecture series 2015-2016 (Utrecht University, NL)

The Postcolonial Studies Initiative is happy to announce its 6th film series with a selection of films, shown monthly, that draw on a variety of different contexts in our postcolonial world. The series is organized annually and invites all interested in our European postcolonial present and the representation of its political, cultural and aesthetic realities and challenges. We want to explore, through visual representations and cinematographic narratives, how these realities are analyzed and re-imagined in contemporary film. Each film will be introduced briefly by scholars connected to the PCI. The PCI Film series started on September 15 with *Those who feel the fire burning* (Morgan Knibbe, NL, 2014). The film was introduced by Christine Quinan and film director Morgan Knibbe was present for Q&A.

The series will take place every third Tuesday of the month, starting with September until April (in Drift 21, room 0.32, from 19.15-21.30 hrs). Admission to the screenings is free of charge.

#### Postcolonial Studies lecture by John McLeod (Utrecht University, NL)

In the lecture series of the Postcolonial Studies Initiative (PCI), John McLeod (University of Leeds, UK) will speak about 'Writing Transcultural Adoption' on 9 October, 2015 (from 13.15–15.00 hrs in Utrecht, NL). John McLeod is Professor of Postcolonial and Diaspora Literatures in the School of English, University of Leeds, UK. He is the author of *Life Lines: Writing Transcultural Adoption* (Bloomsbury, 2015), *Beginning Postcolonialism* (MUP, 2nd ed. 2010) and *Postcolonial London: Rewriting the Metropolis* (Routledge, 2004).

Adoptions that cross the lines of culture, race and nation are a major consequence of conflicts around the globe, yet their histories and representations are rarely considered. While acknowledging the sobering inequalities which engender transcultural adoptions and the lasting upset of sundered relations, John McLeod considers the transfigurative and creative propensity of imagining transcultural adoption in recent literary texts as radically calling into question ideas of biogenetic attachment, racial genealogy, cultural identity and normative family-making. How might the predicament of 'being adopted' transculturally enable the transformative agency of 'adoptive being' for all?

The PCI is sponsored by and connected to Utrecht University's research focus area Cultures, Citizenship and Human Rights. The lecture is free of charge.

#### TC ReadingRoom and lecture Odile Ferly (Utrecht University, NL)

ReadingRoom is a space for careful readings and meaningful conversations around different texts. It was initiated last year by the Utrecht wing of Terra Critica, an interdisciplinary network for the critical humanities, in collaboration with Casco. The second series focuses on relationality as a fundamental condition of critical assessment and intervention today, and is informed especially by Caribbean theoretical, artistic, and social practices. The upcoming gathering on 12 October (17.00-21.30 hrs) features excerpts from *Poetics of Relation* (2006) by Edouard Glissant, a Martiniquan poet, cultural theorist, and key thinker on relation in view of the postcolonial contemporary and a documentary film on Glissant, *One World in Relation* (2010) by Manthia Diawara. Odile Ferly, teacher of Caribbean literature and culture from a comparative perspective at Clark University, Worcester, Massachusetts joins as discussant. #### Postcolonial Studies lecture by Odile Ferly (Utrecht University, NL)

In the lecture series of the Postcolonial Studies Initiative (PCI), Odile Ferly (Clark University, USA) will speak about 'Discursive Mangroves in the Contemporary Caribbean Imaginary' on 13 October, 2015 (from 11.00-12.45 hrs; Drift 21, room 0.05, Utrecht). Dr Odile Ferly received a BA from the University of Bristol, UK, an MA from the Université de la Sorbonne Nouvelle, Paris, and a PhD from the University of Bristol. She has been at Clark since 2004 and is affiliated with the programmes in Communication and Culture, Race and Ethnic Relations, and Women's and Gender Studies. As the breeding ground of numerous fish, birds, crabs and other indigenous fauna and flora, the mangrove is synonymous with life in the Caribbean. Standing out far above ground, its rhizomic trees pick up the brackish water and use it for their growth after exuding the salt. The mangrove therefore symbolizes fertility, growth, and purification.

At the same time, the mangrove is what Bhabha would call a Third Space, marine and terrestrial, at once both and neither. An extension of Deleuze and Guattari's regenerating rhizome and of Édouard Glissant's Relation, the mangrove has inspired many Caribbean intellectuals, shaping their conception of identity.

It is also a metaphor for the female discourse in the Caribbean, which represents a reinvigorating

force in the regional canon. The mangrove thus figures as the common creative matrix from which the aesthetic projects of many Caribbean writers, especially women, have emerged. The lecture is in conjunction with the Terra Critica ReadingRoom. The lecture is free of charge. <u>Read more --></u>

## 10th Anniversary Conference of the Contemporary Women's Writing Association (University of Brighton, UK)

On October 17, 2015, the 10th Anniversary Conference of the Contemporary Women's Writing Association will be held at the University of Brighton (UK). The conference is entitled 'Legacies & Lifespans. Contemporary Women's Writing in the 21st Century'.

The very existence of the term contemporary women's writing suggests a relationship as well as a difference, a continuity, and a radical creative break between women's writing from the 1960's and 70's onwards, and those works of women writers which came before. Simultaneously it suggests writing which captures the evolving spirit and concerns of the twenty first century with experimentation, innovation and speculation.

Contemporary women writers have long explored their present through both the past and the future, through historical explorations of women's lives and worlds, and through imaginary times ahead. This conference seeks to ask what has been the big news of the last ten years in contemporary women's writing, and what may define it in future decades. We hope to explore contemporary women writers' relationships to the past and the future, their continuities, legacies, radical breaks and innovations, including – but by no means limited to – the following topics: historical fiction; utopias / dystopias; feminist genealogies and generations; gendered temporalities; the politics of (re)writing the past and of imagining the future; women's science fiction and fantasy; new genres/ new forms; the future of feminist literary criticism; writing in an age of crisis; defining the contemporary; women's writing and the new technologies; women's writing and the literary market place.

**3 PhD positions 'Digital Crossings in Europe. Gender, Diaspora and Belonging' (1,0 fte each)** You will be working within the project 'Digital Crossings in Europe: Gender, Diaspora and Belonging' (CONNECTINGEUROPE). This project is funded by the European Research Council (ERC), by way of a Consolidator Grant awarded to the principal investigator (PI) Prof. dr. Sandra Ponzanesi (Professor of Gender and Postcolonial Studies, Utrecht University, the Netherlands). The project aims to investigate the relation between migration and digital technologies, in particular the way in which the 'connected migrant' contributes to new forms of European integration and cosmopolitan citizenship. The project explores digital diasporas in relation to issues of gender, ethnicity and affective belonging, focusing on how new technologies enhance new forms of connectivity between the homeland and destination countries, bus also across diasporas. The project pioneers a new interdisciplinary method that combines media studies, postcolonial theories, digital humanities and gender studies, drawing from the humanities and social science. It proposes a comparative approach, based on qualitative digital methods, that focuses on Somali, Romanian and Turkish women migrants who have settled in some of Europe's main cities (London – PhD1, Amsterdam – PhD2 and Rome – PhD3) and the way in which they keep digitally and emotionally connected to their homeland cities (Mogadishu, Bucharest, Istanbul – Postdoc). The project will chart how different forms of migration (labour, postcolonial and post socialist) impact on the new European order at the local and transnational levels.

Within the project, three PhD positions and a postdoc position (advertised separately) will be available for the following projects:

1. PhD1 - Digital Diasporas: London.

2. PhD2 - Digital Diasporas: Amsterdam.

3. PhD3 - Digital Diasporas: Rome.

4. Postdoc: The Politics of Home

The three PhDs will have to conduct fieldwork across the three migrant groups (Turkish, Somali, Romanian) in the proposed city (London, Amsterdam or Rome). The interaction, collaboration and sharing of data with the other PhDs and the postdoc is expected. The PhD and Postdoc candidates will of course have the opportunity to fill in the details of these projects or expand on them, based on their expertise, the data they gather and their own research ideas, all in consultation with the principal investigator.

- Participate in all training programmes and expert meetings scheduled for the project.

#### The 2015 International Symposium on Women's Studies (Warsaw, PL)

# International Congress 'Gender Studies in Debate: Pathways, challenges and interdisciplinary perspectives' (University of Lisbon, PT)

Call for Papers for the International Congress 'Gender Studies in Debate: Pathways, challenges and interdisciplinary perspectives', which will be held on May 25-27, 2016, at the Institute of Social and Political Sciences (ISCSP) of the University of Lisbon (Portugal). We count on you to address questions such as: what impact have had different gender equality policies on the effective implementation of rights? How to ensure the implementation of laws and prevent perverse effects? Power, relations of power, masculine domination and gender: which connections? Are there frontiers between activism and research, and if yes, how/where to draw them? How to balance the collective subject 'women' with ethnic, class, generational, sexual orientation, and global diversity? How is gender performed in daily life and in different institutions: between reproduction and agency? Heteronormativity, bodies, and sexuality: central issue for gender studies? Men and masculinities: new configurations? What backlash effects have the crisis, the increased inequalities and the neoliberal thinking had on the current life of men and women?

We also wish to bring to the debate the contributions of researchers from different parts of the world to help us reflect upon the pathways followed by gender and women studies and feminisms in their geographic, political and sociocultural contexts. The abstracts, no longer than 300 words, should clearly indicate in which research line (I, II or III) the paper should be included. The research lines to consider are the following:

I Gender, feminisms and women studies

II Policies, institutions and citizenship

III Gender and the construction of contemporary societies

#### PhD Defense Arla Gruda (Utrecht University, NL)

**Title:** 'Lone mothers and welfare policies in Albania. Conditions, experiences, expectations. 1944-2013'

Supervisors: Prof. dr. Berteke Waaldijk and dr. Saemira Pino

**Registration:** no registration; free entrance

'Lone mothers' are a women category of all times. Their stereotipization and categorizations is constructed by media and political discourses (such as in UK and US), by policy and decision makers need's discourses (such as in the Netherlands and Germany). But the real identities of lone mothers and their differences within a category stand far from what is being constructed in other political spaces rather than in their own homes. This research, therefore tries to construct the social category of 'lone mothers' in Albania, for purpose of welfare-policy-influencing. It is a feminist action research that endeavors to voice the needs of Albanian lone mothers through their own voice, through the voice of local governmental officers, women activists and religious practitioners, who provide services to them. By voicing their needs, lone mothers display their categorical differences.

Book: *Rethinking Romantic Love: Discussions, Imaginaries and Practices* (Cambridge Scholars Publishing, 2015)

On June 1, 2015, the book *Rethinking Romantic Love: Discussions, Imaginaries and Practices* (eds. Begonya Enguix, Jordi Roca) is published.

This book addresses current conceptions of romantic love in different social groups through different practices and in different countries, and shows that, despite the variability of discourses, experiences and practices related to love, a number of ideas of what love should be like – related to the Western ideals of romantic love – persist in all these contexts. The contributions to this volume are derived from extensive fieldwork and ethnographic research, and will be of undoubted interest for the academic milieu. However, given the topic it deals with, the book will also appeal to the general public, who will find in these pages many 'love stories' derived from the detailed study of the society which we inhabit and the ideals of love that we breathe.

## ARC-GS National Prize for Best Social Science Master Thesis in Gender and Sexuality Studies 2015 (University of Amsterdam, NL)

Launched in September 2010, the Amsterdam Research Center for Gender and Sexuality (ARC-GS) is working to promote gender and sexuality studies within the social sciences at the University of Amsterdam, in the Netherlands and beyond. Aside from facilitating research synergies, its educational mission involves encouraging and valorizing advanced social science students working in the field. The 2015 ARC-GS Prize will award the best gender and/or sexuality studies master thesis in the social scientific disciplines in the Netherlands. Graduates from all over the country are encouraged to apply. Conditions to qualify:

- You have completed your master program in the social sciences (sociology, anthropology, political science, geography, economics, history) within a Dutch university;

- Your thesis must have been completed between October 1st, 2014 and October 31st, 2015;

- Your thesis can be written in English or in Dutch;
- Your thesis must be based on theoretically informed empirical research carried out independently;

- Gender and/or sexuality must be a central element of your research focus;

- Your obtained grade should be 8 or higher.

The prize will be awarded on Thursday, December 10 at the beginning of the ARC-GS monthly lecture, and the amount of the ARC-GS prize is €500. **Deadline** for submission is October 31, 2015.
