Lecture 'Gender Inequality in China' by Dr. Qi Wang (Leiden University, NL)



Dr. Qi Wang (University of Southern Denmark) will talk about gender inequality in China. One of the consequences of China's economic reform and market development over the past decades has been the spread of gender inequality. The lecture aims to assess gender inequality in China today. Why and how has gender inequality taken root in China's transition from socialism to a market economy? And what lessons can we draw from the Chinese experience?

The lecture addresses these questions on the basis of the recently published book *Revisiting Gender Inequality: Perspectives from the People's Republic of China* (Palgrave Macmillan, 2016).

Lecture 'Revisiting Enlightenment Racial Classification' (University of Amsterdam, NL)



On Monday November 28 (15.30-17.00 hrs, Nieuwe Achtergracht 166, Common Room Anthropology B5.12) PhD candidate Devin Vartija will give a lecture on 'Revisiting Enlightenment Racial Classification'. In his research he investigates the tension between ideas of natural equality and racial classification in eighteenth-century encyclopaedias. In the paper I am presenting here, I focus on racial classification in particular and argue that if we analyse the concept of race contextually, then the seeming 'paradox' of Enlightenment discourses of equality and

inequality evaporates. Of course, many eighteenth-century thinkers suffered from colour prejudice but the main function of the concept of race in key Enlightenment texts was to position humanity within the ambit of nature, as a species that possesses a deep history and a physical constitution susceptible to the influence of climate. Race is a biologically meaningless category but we still share something crucial with Enlightenment thinkers — any explanation of human physical diversity must be a naturalistic one. In this regard, as with our commitment to the value of equality, we must position ourselves within the legacy of the Enlightenment.

It explores the social, cultural and political implications of migrant digital practices as grounded in everyday practice. The postcolonial and gender scholars will organise a two-day seminar and a one-day masterclass for advanced PhD students and emerging scholars.

In our contemporary world, migrants should be considered as 'connected migrants'. More than ever before, migrants can chose between different

technologies to be in contact with loved ones living in their country of origin. This colloquium will

innovatively address how digital practices of migrants revolves around the dialectic of 'encapsulation' and 'cosmopolitanism'. World renown emeritus professor Zygmunt Bauman will assess contemporary formations of the internet, diaspora, migration and multiculturalism.

Series of Lectures and Discussions 'Things that Move Us: Affect and Authority' (Heinrich-Heine Universität Dusseldorf, Germany)

Affect – a palpable intensity, the atmosphere in a room – is transmitted between people, below the threshold of conscious perception, manifesting as bodily tension and relaxation. Affect is involuntary, non-conscious, contagious, and to a certain degree automatic. Affect's political potential has been investigated with renewed intensity from gender and queer studies perspectives in the previous fifteen years. Scholars working along these lines focus particularly on negative affects such as shame, fear, outrage, depression and failure, asking the question: how can negative affects be (made) productive? They consider the enabling moments produced by choosing not to turn away from these affects, critically investigate their societal causes, and explore the creative employment of these intensities. These foci of investigation speak to the broader question: how can affects facilitate a thinking process? The lectures in this series address this question by exploring how affects are transmitted and negotiated in media cultures, how they enter scholarly practice, and what is the relation between scholarly authority and affect.

InterGender course 'Decolonial feminisms' (Linköping University, SE)

InterGender, Consortium and Research School in Interdisciplinary Gender Studies, organizes a course for PhD students and Master students. Title



of the course is 'Decolonial feminisms' and the course will be held from February 22-24, 2017, at Linkoping University (Sweden). The course will introduce the decolonial option as a contemporary non-western critical thought and practice. We will dwell on the key concepts and tools of decolonial analysis, particularly in relation to Western and other non-Western feminisms. The course will also consider intersections and differences in various kinds of decolonial feminist critique stemming from diverse local histories, geopolitics and corpopolitics of knowledge, being and sensing. The course is divided into three interrelated strands. The first strand will discuss the seminal decolonial feminist texts; the second strand will focus on indigenous feminisms in Mesoamerica and the third strand will explore the possibility of applying decolonial tools in the context of postsocialist Eastern Europe. In particular, this strand will consider whether decolonial framework could be a useful thinking technology to trouble the Western-centric and universalizing tendencies characteristic to certain predominant articulations of transnational feminisms that commonly attribute a lag narrative to Eastern Europe.

Focusing on policy issues such as domestic violence, forced marriage, reproduction, migration and poverty, this project explores:

- the way in which gender equality is included in, and excluded from, policymaking institutions and processes;
- the relation between, and the relative importance of, the European and the national level;
- the impact on gender equality.

The project is connected to three overlapping international networks of scholars, practitioners, and activists: Re-integrating Gender in the EU; the (In)visibility of Gender in the European Union; and Gender Equality Policy in Practice.

Why isn't my professor black?'
