Eva Hayward is an assistant professor in Gender & Women's Studies at the University of Arizona, Tucson. Receiving her Ph.D. in History of Consciousness at UC Santa Cruz (2008), she has taught at the University of California, Santa Cruz, University of New Mexico, and University of Cincinnati. She held postdoctoral fellowships at Uppsala University (Sweden) and Duke University. Her research focuses on aesthetics, environmental and science studies, and sexuality studies. At the University of Arizona, she has taught course on Feminist Animal Studies, Environmental Studies, Transgender Studies, Queer Cinema, and Sexuality & Aesthetics. She has recently published articles in *Angelaki, Transgender Studies Quarterly, Cultural Anthropology, Parallax, differences*, and *Women's Studies Quarterly.* Hayward's forthcoming book "SymbioSeas" looks at underwater representations of marine organisms to think about the interplay of sexuality and animal sciences, specifically how the unknowability of "the Animal" is sexually oriented in laboratory research and display practices.

Public Lecture: "Is Secularism Bad for Women? Women, Religion and Secularism in Contemporary Europe" with Kristin Aue (Utrecht University, NL)



Organized by Graduate Gender Programme (GGeP) at Utrecht University.

How to secure both gender equality and religious freedom is a crucial, yet neglected, topic. This talk will argue that asking 'Is secularism bad for women?'enables these issues to be discussed in a new way. Attempts to provide a 'yes' or 'no' response are inadequate, so the essay proposes methodological steps towards an answer. It will introduce debates from the newly-published 'Is secularism bad for women?' special issue of the journal *Social Compass*,

developed from a workshop series funded by the International Society for the Sociology of Religion.

Dr. Kristin Aune is Senior Research Fellow at the Centre for Trust, Peace and Social Relations, Coventry University, UK. Her research is on religion, gender and higher education, and she has published widely on these topics. Her books include *Religion and Higher Education in Europe and North America* (Routledge, 2017, ed. with J. Stevenson), *Reclaiming the F Word: Feminism Today* (Zed, 2013, with C. Redfern) and *Women and Religion in the West: Challenging Secularization* (Ashgate, 2008, ed. with S. Sharma & G. Vincett).

PhD opportunity - Trans Inclusion in Education (University of Strathclyde, Glasgow, UK)

The PhD will explore strategies for the development of awareness, and practices of inclusion, of trans and non-binary issues and identities in education. Despite increased research and policy attention, trans awareness in primary and secondary education remains at a preliminary stage. Likewise,



alongside the continued work of trans scholars and activists, Trans Studies is largely absent from UK universities, trans invisibility prevails in curricula of most subjects, and trans inclusive pedagogies are in need of development. While there has been increased policy and research attention to LGBT educational equalities in the UK in recent years, the 'T' of LGBT is often subsumed within the acronym, and trans

struggles are subject to sustained and virulent backlash. In order to challenge both entrenched transphobic prejudices and normative essentialising understandings of gender as binary among teachers, pupils, and in wider social context, an array of practical strategies for change are needed to help educational fields become meaningfully inclusive of trans children, students, and staff.

Call for Papers: Ev'ry Body, This Time: A Sexuality Studies Conference (University of California, Berkeley, USA)



"Ev'ry Body, This Time." The elision in ev'ry gestures in multiple ways: to the bodies that have been exempted in various iterations of sexuality studies, and to our quixotic desire to (re-)emplace them. It refers as well to the shifting and ever-proliferating fact of bodies: the way that apparent gaps may not represent incompleteness, but point instead to troubled standards of perceiving or evaluating wholeness; that filling a gap can thus provisionally flesh out bodies that are at once legible and illegible. Race and gender, in their mutable

complexities, sit at the core of these questions. Our apostrophe calls to a multitude of bodies, recognizing the potential for thinking through, substituting, re-visioning, and, ultimately, holding space for, bodies that exceed categorical legislation and rhetorical disciplinarity. We also note that embodiment is not everyone's cup of tea. We flag the body, ev'ry body, because sensuousness has too often been left out of considerations of sexuality and politics. Simultaneously, we wonder how given languages about sex and meaning work in relation to disability, debility; in the realm of the digital; under the aegis of asexuality?

At the same time, academic LGBT and queer scholarship in fields such as criminology, criminal justice studies, sociology, and socio-legal studies, has grown significantly.


We welcome proposals from academics as well as practitioners working in the field. We particularly welcome proposals from those in the Global South. The conference is an opportunity to bring together researchers, community members, and organisations working at the intersections of sexuality, gender diversity, and justice, broadly conceived.

The conference will be held at the University of Sydney, Australia, from 11-13 July, 2018.

We invite abstract submissions for oral presentations, panels, or roundtables at this conference that respond to the above considerations. Abstract submissions should include information about the author(s), their institutional affiliations, their contact details, and a 300 word (maximum) abstract. Abstracts must be submitted by email (queeringjustice@gmail.com) no later than Friday 2 March, 2018. Acceptance of an abstract will be advised by Friday 16 March, 2018. Selected presentations will also be considered for publication in an edited volume after the symposium.

Call for Papers: Special Issue of *Journal of Gender Studies*: Biopolitics, Necropolitics, Cosmopolitics: Feminist and Queer Interventions



This special issue aims to both address these urgent issues and open them up onto new ways of imagining vital politics, resistance strategies, and other-than-merely-human agencies. In this way, we envision feminist and queer interventions that rethink categories such as 'human' and 'subjectivity' based on the classical modern premises. We offer 'cosmopolitics' (Stengers 2005, Haraway 2008, Gilroy 2010), which is not to be mixed up with traditional 'cosmopolitanism', as a fruitful critical posthuman(ist) and post-/decolonial approach to thinking through biopolitical and necropolitical networks and assemblages that assign life- and death-giving force. This special issue hopes

therefore to produce resilient visions of transformation of the matrix of in-/exclusion into feminist/queer cosmopolitical futures that contribute to a new discourse of planetary social justice.

We hope for engagements with art, literature, philosophy, media, and cultural artifacts, and both humanities- and social sciences-informed approaches are welcomed.

Announcement journal special issue 'Connected migrants' in Popular Communication



Introduction to the issue:

This special issue features digital migration research as first presented during the Connected Migrants Academy Colloquium and Masterclasses that took place December 14–16, 2016, at the Royal Netherlands Academy of Arts and Sciences (KNAW) in Amsterdam, the Netherlands. Taking a cue from Dana Diminescu's seminal manifesto on "the connected migrant," this special issue introduces the notions of encapsulation and cosmopolitanism to understand digital migration studies. The pieces here present a nonbinary, integrated notion of an increasingly digitally mediated cosmopolitanism that accommodates differences within but also recognizes Europe's colonial legacy and the fraught postcolonial present. Of special interest is an essay by the late

Zygmunt Bauman, who argues that the messy boundaries of Europe require a renewed vision of cosmopolitan Europe, based on dialogue and aspirations, rather than on Eurocentrism and universal values. In the introductory article, we focus on three overarching discussions informing this special issue: (a) an appreciation of the so-called "refugee crisis" and the articulation of conflicting Europeanisms, (b) an understanding of the relationships between the concepts of cosmopolitanization and encapsulation, and (c) a recognition of the emergence of the interdisciplinary field of digital migration studies.
