#### One-Year PhD Training in Gender Studies (Utrecht University, NL)

The Netherlands Research School of Gender Studies (NOG, Utrecht University) offers a one-year interdisciplinary programme (10 months) for graduated MA students and PhD students from abroad. The training package consists of NOG courses and research seminars. All courses are taught in English from multicultural, (Western) European perspectives. A certificate is issued after completion of each individual course. Please note that this training doesn't officially constitute a MA or PhD degree, although an ECTS system is in place. The Dutch academic year runs from September to the end of June. The one-year PhD Training starts yearly in September.

Pre-requisite for admission: A Master's degree or the equivalent of a M.A. in gender or gender-related areas. The NOG Board will make a profound evaluation about the global value of your foreign higher education.

#### Lecture Ala'a Basatneh in Doing Gender Lecture Series Spring 2014 (Utrecht University, NL)

In the spring of 2014 the Netherlands Research School of Gender Studies (NOG) in cooperation with the Graduate Gender Programme (GGeP) at Utrecht University organises the twelfth round of the Doing Gender Lecture Series. These lectures stress the importance of doing gender work combined with an active involvement in the practice of gender theory and research. Ala'a Basatneh (Loyola University of Chicago) will give the upcoming Doing Gender Lecture on Tuesday March 25, 2014. The lecture is entitled 'How to start a Revolution?' and will be held at Utrecht University from 16.00 - 17.30 hrs. This lecture is jointly organized with [Movies that Matter](#).

The Syrian Ala'a Basatneh is a 21 year old student pursuing her Bachelor Degree in political sciences at the Loyola University of Chicago. Next to her academic activities, she is also a human rights and political activist, playing an important role in the Syrian Revolution. From behind her

computer, she has been helping coordinating the revolution through diverse forms of social media. And with 1,200 Facebook friends and 2,000 followers on Twitter, she has built up an impressive network. She posts demonstrations as Facebook events, plots escape routes using Google Maps and uploads footage shot by demonstrators. She also ensures that all kinds of recording equipment get to her friends, once ordinary students who now want to overthrow the rule by terror of President Bashar al-Assad. During the lecture, Ala'a will talk about her personal experiences and explain how she organizes this revolution using social media. She will comment on the increasing restriction of women's rights by Syrian extremists in the north of Syria and discuss social media as a new form of activism.

The Doing Gender Lecture Series takes place in Utrecht and is free of charge. Registration is not compulsory, but highly appreciated.

### Lunch Lecture: Queer Paradigms and 'Different Normativities' in China and Beyond (University of Amsterdam, NL)

The Amsterdam Research Centre for Gender and Sexuality ARC-GS organizes a lecture including lunch on March 6, 2014, from 12.00 - 14.00 hrs. Elisabeth L. Engebretsen will give the lecture, entitled 'Queer Paradigms and "Different Normativities" in China and Beyond'. She received her PhD in Anthropology from the London School of Economics where she also gained an MSc in Gender Studies. She is currently a Research Fellow at the International Institute for Asian Studies in Leiden, working on a project on urban poverty, graduate unemployment and well-being in China.

Using the case of same-sex marriage strategies in contemporary China, this talk explores two key questions: why and how is it that the globally travelling 'gay marriage equality' discourse has met with reluctance locally in China? Furthermore, could normal life - exemplified by the popularity of complicit marriage strategies among Chinese queers - ever be really 'queer' (enough)? In this talk Engebretsen appropriates Ching Yau's notion of 'different normativities' as a way to critically investigate the usefulness of 'queer' and its divergent manifestations in scholarship and activism, especially in the context of determining transgressive and conformist practices, and in the complex project of recognizing (sexual and gender) difference.

### **InterGender Research School Course (University of Karlstad, SE)**

InterGender is a consortium of international partners (amongst other the NOG, Netherlands Research School of Gender Studies) which offers a large scale research training programme meeting the needs of PhD students in different phases of their training. The InterGender Research School is happy to announce the following course taking place during spring 2014: 'Revisiting 'doing gender': Language and Gender in Interaction'. The teachers are Don Kulick (Professor of Anthropology, University of Chicago, USA), Ann-Carita Evaldsson (Professor of Education, Uppsala University, Sweden) and Erica Sandlund (Senior lecturer, English Linguistics/affiliated researcher, Center for Gender Studies, Karlstad University, Sweden). The course is held at the University of Karlstad, Sweden, from May 6-8, 2014.

The course centers on exploring key aspects of the relationships between language, gender, and social interaction. Current and earlier debates in the area of language, gender and interaction are revisited with a focus both on the commonalities and differences between different approaches. Providing methodological discussions and illustrative examples on how researchers go about collecting and analyzing data, the overarching focus of the course is how gender issues and other

forms of inequalities have been addressed in recent discourse research. We will pay particular attention to research on language and sexuality, enactments of differences, and on interactional accomplishments of gender in various settings. A core idea behind the research examined is the ethnomethodological concept of 'doing gender' that had been present in some form since mid-seventies and firmly established during the 1990s. The course will, firstly, investigate the relationship between language and gender, both theoretically and empirically. Secondly, the course encompasses research using an ethnomethodological and conversation analytic approach in the study of identity and interaction. The course is aimed at doctoral students in gender studies and related fields, suitable for anyone with an interest in how gender is 'done' in language and embodied action as well as for anyone working with or is interested in working with spoken language data (recordings) in their own research.

### **LOVA International Summer School 2014 and Writing Workshop (Amsterdam, NL)**

The LOVA International Summer School 2014 will be held from June 30 - July 4, 2014, in Amsterdam. The focus lies on 'Body Work(s)': the lectures concentrate on the body in ethnographical research. Most of the workshops pay attention to the improvement of the presentation skills we all need in daily life and working environments, where students are used to social media, and infotainment is gaining ground in our classrooms. Through fieldtrips you gain knowledge of the culture and history of Amsterdam. You will study hard and reflect on your own research projects. Our principle objective is to train you in ethnographic research methods and to bring students and life long learners in touch with gender scholars and anthropological perspectives on feminist, queer and gender studies. With our hands-on approach and interactive workshops we encourage critical thinking and discussion with your fellow participants and tutors.

Additional to the LOVA ISS 2014 we offer a writing workshop from July 7-8, 2014. The workshop is

meant for those of us, who are in need of writing methods, a space to free-write and to concentrate on our writing goals. We guarantee small groups and the courses and workshops are in English.

### Lecture Jacqueline Scott 'Conflicting Family Interests: A Challenge for Family Policy' (University of Antwerp, BE)

On March 19, 2014, from 19.00-21.00 hrs Jacqueline Scott will give a lecture entitled 'Conflicting Family Interests: A Challenge for Family Policy' at the University of Antwerp, Belgium. Scott is Professor of Empirical Sociology, Faculty of Politics, Psychology, Sociology and International Studies, Queens' College, Cambridge. In her lecture, she focusses on the crucial interlinks between family members in terms of changing norms in partnerships and parenting. The paper on which the lecture is based has three parts. First she discusses how partnerships and parenting are informed by changing gender roles. She examines gender role change in terms of both public attitudes and work-family conflict. Second, she explores the evidence on changes in parenting across time, with reference to young children and adolescents. Third, she brings together these gender and generational perspectives to examine how family life can impinge on the wellbeing of different family members. In the conclusion, Scott argue that the various interests of family members can conflict in a way that poses challenges for contemporary family policy. Welfare systems were originally based on the assumption of a stable family and a gendered division of labour. Such assumptions are clearly problematic. It is therefore a contentious issue as to how family policy can best support partnerships and parenting.

### Intensive Workshop 'Equality, Inclusion and Its Discontents' (Utrecht University, NL)

Although structural social, cultural and economic inequalities obviously exist, we cannot assume to know their inner workings and precise effects. Patterns of in- and exclusion are surprisingly rigid and flexible at the same time. Women and other underprivileged subjects carry the 'sticky signs' (Ahmed 2004: 92), of histories of exclusion and inequality .Throughout the major institutional transformations and crises of several centuries, gender and ethnicity have shown great resilience as categories of in- and exclusion. This necessitates research methodologies which allow for both generalization (social and economic history, statistics, cohort studies, comparative research, economics) and case studies (historical and cross-cultural comparisons, ethnography, affect studies).

On April 16, 2014 an intensive workshop will be held, from 13.30-17.00 hrs in Utrecht. The steering group of the Strategic Theme Institutions of the Open Society (IOS) pillar Equality, Inclusion and Social mobility (EIS) has invited three UU scholars to present their interdisciplinary and jointly executed research plans as well as intended research proposals to the wider Institutions community. UU and other researchers are cordially invited to join this intensive workshop in order to get an insight in the way in which multidisciplinary analysis is deployed within the Humanities, Anthropology and Law studies in order to analyse processes of in- and exclusion at the intersections of public and private domains. Additionally, participants are invited to discuss the proposed projects and possibly become partner in one of the envisioned research applications to be submitted and/or conferences to be organized. The central question which will be addressed in the Intensive Workshop is: What happens when new institutional, cultural and social practices challenge and redefine distinctions between public and private? How do the struggles for new institutional forms interact with patterns of in and exclusion along lines of gender and ethnicity?

Speakers and referents include Dr. Susanne Burri (Law, UU), Dr. Marieke van Eijk (Gender Studies, UU), Dr. Deen Freelon (Mediastudies, University of Washington), Dr. Mirko Schäfer (Mediastudies, UU), Prof. dr. Berteke Waaldijk (Gender Studies, UU). The afternoon will be chaired by Prof. dr. Rosemarie Buikema (Gender Studies, member of the steering group EIS).

### **NOG National Research Day 2014 'Doing Gender in the Netherlands: Feminism in Transition (Activism, Institutions and Canons)' (University of Amsterdam, NL)**

The Netherlands Research School of Gender Studies (NOG) would like to invite you to the annual National Research Day, on May 23, 2014. The day is dedicated to the cutting edge work of junior researchers of Dutch universities in the field of Gender, Ethnicity, Sexuality and Diversity. This year the National Research Day will be hosted by our colleagues of the Amsterdam Research Centre for Gender and Sexuality (ARC-GS, University of Amsterdam). The *Doing Gender in the Netherlands Day* is open for presentations of PhD students, postdocs and advanced research master students registered at Dutch universities. There are several options to participate: as a paper presenter, as a listener, and as a referee.

### **International Conference of the International Association for Gender Equity (Accra, GH)**

Call for papers for the International Association for Gender Equity (IAFGE) 2014 International Conference (the 4th Conference) on April 7-11, 2014 at Accra, Ghana. The theme is 'Capacity Building for Gender Equality and Women Empowerment'. The theme is carefully chosen to emphasize the strategic role of human resource in the development of any nation. In agreement with Groot and Moolen (2001), focusing on gender capacity building involves planned development of knowledge, skills and attitudes in individuals and groups of people, without prioritizing the male or female gender. Consequently, the objectives of IAFGE 2014 include the following:

- Educate participants on the need/importance of capacity building for self and national development.
- Provide a forum for a re-think that demands all stakeholders to focus on effective planning, review and implementation of gender-responsive development programmes.
- Establish linkages between individuals/groups in the effort to achieve a non-gender biased environment for successful living in society.
- Ability to be relevant in the design, development and maintenance of societal institutions such as socio-economic and political institutions as well as existing meaningful operational infrastructures and processes in the environment.
- Educate every individual, male and female, on the importance of identifying and developing his/her potentials for meaningful contribution to societal development.
- Knowledge of the challenges facing effective capacity building and ways to overcome them.

Considering the multidisciplinary nature of the theme and for effective coverage of related discussions, well-researched empirical and theoretical papers to be presented at the conference are expected to include such areas as philosophical and theoretical considerations, education, continuing education, mentoring, curriculum, evaluation, training and retraining, skill acquisition, management, policy formulation and programmes as well as psychological and counseling issues, monitoring, review, health, industries, entrepreneurship, mainstreaming, women's work, mentoring, socio-cultural institutions, etc. You are free to contribute on other areas of interest that are not listed but must be within the scope of the theme.

### International Conference 'Material Matters in Times of Crisis Capitalism' (Justus-Liebig University, Giessen, GE)

Call for papers for the international conference 'Material Matters in Times of Crisis Capitalism: Transnational Feminist and Decolonial Approaches' at the Justus-Liebig University in Giessen, Germany, on November 13-15, 2014. The question of materiality has emerged as a central topic in studies concerned with the body, affect, sexuality, bio-politics and digital culture in recent years. Under the umbrella term 'new materialism', this interdisciplinary and multifaceted academic debate seems to have revived a Marxist vocabulary. Yet, the question of why 'materiality' matters in times of crisis capitalism is rather absent in this debate. This conference takes up this question by focusing on why and how materiality matters in times of crisis capitalism. Starting from the assumption that crisis is not exceptional in capitalism but its constant companion and that it represents the foundation from which the modern/colonial world system has evolved, this conference draws on critical feminist economics and decolonial feminist thought and practice on material matters.

The conference has three inter-related aims: first, to examine from transnational feminist perspectives the impact of the global crisis on people's livelihoods; second, to explore the theoretical contributions of the triad of feminism, coloniality and political economy; and, third, to consider critical feminist economics and decolonial approaches to thinking alternative economies and convivial futures.
