### Lecture Beauvoir in Transit: Reading The Second Sex Translingually (Radboud University, NL)

The Graduate School for the Humanities & Institute for Gender Studies of Radboud University Nijmegen (the Netherlands) proudly presents: Radboud Gender Studies & Sexualities Lecture IV: "Beauvoir in Transit: Reading *The Second Sex* Translingually" a lecture by Kyoo Lee (CUNY, New York). The lecture will be held on 26 November 2014, from 16:00-18:00 hrs.

Who has not heard of this: "One is not born, but rather becomes, a woman" (Le deuxième sexe, The Second Sex)? Who does not understand this, arguably most famous and powerful slogan of (French) feminism? However, a closer and rigorously "translingual" analysis of the line reveals that it is yet to be fully understood and its propositional power, yet to be unleashed more fully. In her lecture, Kyoo Lee explores the queer simplexity (simple complexity) of the genius of Beauvoirean gender thinking that is second Kyoo Lee is the author of Reading Descartes Otherwise: Blind, Mad, Dreamy, and Bad (2012) and Professor of Philosophy at the City University of New York. Trained in European Philosophy & Literary Theory, she writes widely in the intersecting fields of the Arts & the Humanities. Her current projects include three books on Daodejing (Laozi), The Passions of the Soul (Descartes), and The Second Sex (de Marieke Borren and Iris van der Tuin will respond. Marieke Borren teaches philosophy at various Dutch universities. Her expertise lies in the areas of political philosophy and philosophical anthropology. Iris van der Tuin is Associate Professor in Gender Studies and Philosophy of Science

Twee Performances: "Men on the Line: Men Committed to Feminism, KPFK, 1972" (Amsterdam, NL) en "Their desire rang through the halls and into the tower" (Utrecht, NL)

Casco – Office for Art, Design and Theory en If I Can't Dance, I Don't Want To Be Part Of Your Revolution presenteren twee performances door kunstenaars uit verschillende feministische generaties. Eén performance vindt plaats in Amsterdam en de ander in Utrecht.

Men on the Line: Men Committed to Feminism, KPFK, 1972 (2012) is een werk van kunstenaar Andrea Fraser. Het is gebaseerd op een live radio-uitzending uit 1972 waarin vier heren een discussie voeren over het belang van de feministische beweging voor mannen. In hun gesprek vragen zij zich af hoe zij zich verhouden, of niet verhouden, tot hun vrouwelijke tegenhangers en reflecteren ze op de angsten en worstelingen die zich in hun levens voordoen. Fraser transcribeerde en bewerkte de uitzending tot een performance, waarin zij zelf alle vier de mannen speelt. In Men on the Line werpt Fraser licht op de hinder die mannen ondervinden wanneer zij over de grenzen van hun eigen sekse heenkijken en zich proberen in te leven in feministische kwesties. De Amsterdamse presentatie van Men on the Line is op dinsdag 2 december 2014 om 20.00 uur bij De Balie. Kaartjes zijn hier te bestellen.

Their desire rang through the halls and into the tower (2014) is een gesproken performance van kunstenaar Alex Martinis Roe. Het werk behandelt twee met elkaar verweven geschiedenissen: het levensverhaal van Anna Maria van Schurman, die als eerste vrouwelijke student in Europa in de zeventiende eeuw studeerde aan de Universiteit Utrecht, en de twintigste-eeuwse ontwikkeling van de Nederlandse Onderzoekschool Gender Studies aan dezelfde universiteit. Martinis Roe schreef een script gebaseerd op bronnenonderzoek en mondelinge geschiedenissen die zij optekende. Het script werd geredigeerd door de studenten van het Gender Studies Programme van de Universiteit Utrecht. Zij voeren tevens de performance op. Het collectieve werk, het script en de performance vormen zo samen een politieke compositie die het gelaagde en onvolledige verhaal schetst van de

gender-emancipatie door de eeuwen heen. De avond op woensdag 3 december 2014 gaat om 20.00 uur bij Casco in Utrecht van start. Voorafgaand aan de performance vindt er een screening plaats van één van Alex Martinis Roe's eerdere werken uit dezelfde serie, *A story from Circolo della rosa* (2014). Ook zal de kunstenaar een introductie geven op haar werk en praktijk. Toegang voor dit evenement is gratis, maar reserveren via email is verplicht.

## Kitchen Table Seminar met Dr. Iva Bicanic over Centra Seksueel Geweld (Atria Amsterdam, NL)

Op donderdag 4 december, van 16.30 tot 18.00 uur, presenteert Iva Bicanic in de Kitchen Table Seminar de totstandkoming en werkwijze van het multidisciplinaire Centrum Seksueel Geweld (of Rape Crisis Center). Dr. Iva Bicanic, psycholoog en onlangs gepromoveerd op het onderwerp verkrachting bij adolescenten stond aan de wieg van het eerste Centrum Seksueel Geweld in Utrecht, opgezet in januari 2012. Het centrum biedt dag en nacht hulp aan iedereen die kort geleden aanranding of verkrachting heeft meegemaakt. In het bijzonder wordt in de presentatie ingegaan op het voorkomen en behandelen van een Post Stress Stoornis (PTSS). blijkt uit onderzoek Traumatische Zo onder vrouwelijke verkrachtingsslachtoffers dat 94% na één week ernstige posttraumatische stress symptomen had. Dit percentage nam af tot 65% na één maand en tot 47% na drie maanden. Bij slachtoffers die eerder zijn misbruikt of eerder psychiatrische problemen hadden, of een groepsverkrachting hebben meegemaakt, liggen deze percentages zelfs hoger. De presentatie wordt afgesloten met informatie effectieve traumabehandeling voor verkrachtingsslachtoffers. afloop borrel. Na van het seminar is er een Aanmelden via email.

#### Re-assembling the Memory Box? A Seminar with Alec Badenoch (Utrecht University, NL)

The Utrecht Forum for Memory Studies (convenors Susanne Knittel, Ann Rigney, Ton Robben) (supported by <u>Utrecht University Focus Area: Cultures, Citizenship, and Human Rights</u>) organizes the Transnational Memory Seminar: "Re-assembling the Memory Box? Transnational Radio Encounters in the Age of Digital Heritage" by Alec Badenoch (Assistant Professor in Media and Cultural studies at Utrecht University) on December 11, 2014 in Utrecht.

Radio presents a paradox with regard to nations. On the one hand, throughout its protean history, radio broadcasting, particularly in Europe, has been shaped by a number of transnational processes, including frequency allocations and appropriations, explorative listening practices and the circulation of programmes. On the other hand, through its embedding and archiving in national institutions, and a number of routine uses (and re-uses), radio has come most strongly to support national memory narratives as both signifier and medium. As digitization and online access offer new possibilities to re-assemble radio memories, will these once more re-inscribe the nation, or can we also use them to open up transnational experiences from the past or even generate new transnational encounters? To explore these questions, this talk will introduce and bring together work from a number of different projects: Badenoch's PhD research on radio and the reworking of memory in post-war Germany; the transnational online exhibit Inventing Europe, and the current HERA collaborative research project "Transnational Radio Encounters".

# Lecture "Progression: Time and the Materialisation of HIV in Canadian Law" by Dr. Emily Grabham (University of Amsterdam, NL)

The Amsterdam Research Center for Gender and Sexuality (ARC-GS) presents their December 2014 Lecture "Progression: Time and the Materialisation of HIV in Canadian Law" by Dr. Emily Grabham (Reader in Law, Kent Law School, University of Kent). The lecture will be held on December 11, 2014, in Amsterdam.

It is by now a very familiar move for scholars working at the intersection of law, science, and technology to follow nonhuman actors of various types - drugs, patents, documents, for example, in addition to our familiar legal friends, humans. Yet this kind of work also inevitably shifts how we understand law and time. If what is often termed in science and technology studies the 'cast' of actors is expanded, then we must grapple not only with temporalities that operate in the domain of human legal consciousness and subjectivity, but also those temporalities which are co-produced

between legal actors of different types, species and registers: human and viral, for example. By following nonhuman legal actors such as proteins, reference materials, the human immunodeficiency virus (HIV), and drugs (e.g., AZT), we can re-evaluate what legal temporalities are, what they do, and where they come from. Specifically, this paper argues that the achievement of progression, and the performance of 'progression work', has been central to the creation of medico-legal objectivity around HIV. Indeed, following van Loon and Jane Bennett, we might say that progression was a means of indexing the conative actions of the HIV retrovirus in legal assemblages, making the virus legally amenable, and effectively connecting law to reality. The lecture is free and open to the public. Registration is not required.

# Training school for young scholars (PhD students and postdocs) in Memory Studies (Vytautas Magnus University, LT)

The Research Network *In Search of Transcultural Memory in Europe* (ISCH COST Action IS1203) welcomes applications for a training school for young scholars in memory studies, who wish to participate in the Network's research activities. The training school will be held from April 14-18, 2015, at the Vytautas Magnus University in Kaunas (Lithuania). The aim is to introduce young scholars to the Network's theoretical and methodological approaches following the successful practice of the project that took place in Copenhagen, Skopje, Paris, and Budapest.

The Research Network In Search of Transcultural Memory in Europe is a COST funded Action that aims to go beyond the nationally oriented memory studies and tendencies to reify the bond between culture, nation and memory. Instead we investigate the transcultural dynamics of memory in Europe today. The training school will consist of:

- The seminar "How to apply for external funding?" with experienced evaluators and former grant holders who will share their knowledge in the domain of project applications for research projects funded by EU.
- A workshop during which PhD students and postdocs will get their papers discussed and commented by the specialists.
- A series of lectures discussing problems of agency and transcultural memory in Europe.
- A half day guided visit to sites of memory in the capital Vilnius.

If you are interested in participating in this training school, please send an application including a cover letter stating your motivations for participating, your CV and an abstract presenting your research (max 500 words). The Network is able to offer a number of grants (900 EUR each) to cover travel and accommodation expenses. Please indicate in your application if you will need a grant.

Based in the Netherlands, NICA is dedicated to Cultural Studies or Cultural Analysis, the academic study of contemporary culture from an interdisciplinary, theoretical, and critical perspective. The Universities of Amsterdam (both University of Amsterdam and Free University Amsterdam), Utrecht, Nijmegen, Groningen, Maastricht and Rotterdam all participate in the school. ### Difference that makes no Difference: The Non-Performativity of Intersectionality and Diversity (Frankfurt, DE)

Call for papers for The International Workshop *Difference that makes no Difference: The Non-Performativity of Intersectionality and Diversity*, which will be held on February 5, 2015. The workshop is organizes by the Frankfurt Research Center for Postcolonial Studies (FRCPS) in cooperation with the Women's Network, Excellence Cluster "The Formation of Normative Orders" (Goethe University Frankfurt). Keynote speaker is Prof. Dr. Sara Ahmed (Goldsmiths, University of London).

Despite the hype of intersectionality and diversity, they remain predominantly symbolic commitments in academic discourses and institutional practices. The rhetoric of diversity is employed to deflect charges of racism and hetero/sexism, even as there is systematic resistance against the institutionalization of diversity. Despite commitments to "do diversity" and to be diverse, discourses and institutions sustain the status quo through Eurocentric and Androcentric academic curricula and discriminatory hiring practices. The aim of this workshop is to explore the ideological function of diversity and intersectionality as legitimizing performance indicators in academic discourses and institutions. We invite paper proposals that address the issue of non-performativity of diversity and intersectionality. A limited number of travel bursaries will be provided for paper presenters (preference will be given to applicants from the global South).

Call for papers for the workshop *Politics of Memory* of the EU Global Governance Programme/RSCAS(EUI) and COST Action IS1203 In search of transcultural memory in Europe (ISTME). This workshop will be held on June 19-20, 2015, in Florence (Italy).

This workshop wants to explore the different dimensions involved in shaping EU memory policies: the conflicts on diverging and often contested memory facts and their projection to the EU/European level; the role of different group of actors as memory entrepreneurs at the supranational level, their cooperation and competition; the role of EU institutions; the strategies pursued by actors and institutions; the fitting of EU policies with national policies, etc. The workshop

invites papers analyzing specific policy issues (denial of crimes, EU memory museum policies, comparing different national cases of actors/strategies in pursuing these European policies, theoretical papers, etc. Single country cases are not preferred although submissions may be considered and decided upon on the basis of their merits. **Deadline** for submission of applications is November 30, 2014.

#### Conference Youth, Media and Diversities (Brussels, BE)

Call for Papers for the International Conference YMdiv: Youth, Media and Diversities, which will be held on April 2-3, 2015, in Brussels (Belgium). Diversity is either considered as a situation in which our societies exist or as a value to be promoted; however as a concept, it remains polysemous and complex. The definition of diversity comes back to the character of what counts as diverse, varied and different. Yet, the term is commonly used to refer to categories of citizens marked by the singularity of their geographic, sociocultural or religious origins or background, by their age or gender, etc. But diversity is also associated with heterogeneous practices — in short, to plural practices. Continuing previous research undertaken by the *Centre d'études sur les jeunes et les médias* (Centre for Youth and Media Studies) and its partners IHECS and Media Animation, the *Youth and Media diversities* (*YMdiv*) Conference aims to focus on relationships between the young and diversity via media. on three levels:

- Micro: the level of reception and of various experiences of diversity via media practices Diversity of practices, practices of diversity
- 2. Meso: the level of the production of diversity, whether it is reached within professional practices or by content creation Media and the diversity of production: visibility and content
- 3. Macro: the level of cultural, educative and communication industries in a transnational perspective Cultural and educative industries through the prism of diversity.

For this conference, multidisciplinary and international approaches will be highly appreciated. In order to offer a powerful and critical look at these issues, a discussion will be engaged with social and political actors in the professional media world. **Deadline** for submission is December 17, 2014.

Call for papers or panels for the Hypatia 2015 Conference, which will be held on May 28-30, 2015, at Villanova Conference Center, Villanova University, USA. This year's theme, *Exploring Collaborative Contestations*, aims to create a space for diverse perspectives, difficult conversations, and marginalized voices within feminist philosophy. We welcome papers and panel proposals on topics that address: a commitment to diversity, broadly construed; an openness to disagreement among feminists on difficult issues; and opportunities for collaboration among feminist philosophers within and across various disciplines, subfields, and theoretical orientations. - Engaging disability studies within philosophy: ethics, politics, epistemology, metaphysics
- Exploring new connections with philosophies of race and ethnicity
- Theorizing LGBTQ coalitions among philosophers and within philosophy
- Working through and across borders of disciplines: interdisciplinarity, transdisciplinarity, and multidisciplinarity
- Building on constructive disagreements within feminist philosophy
- Exploring new connections for feminist theorizing: activism, youth movements, transnational alliances
- Challenging philosophical subfields
- Occupying: resistance and repercussions in the profession

#### Research programme Sexual and Reproductive Health and Rights (Utrecht University, NL)

The NWO-WOTRO calls for research projects on Sexual and Reproductive Health and Rights (SRHR) in Bangladesh and Burundi. The Sexual and Reproductive Health and Rights (SRHR) research programme aims to generate insights in and a better understanding of processes that determine and strengthen the sexual and reproductive health of people, as well as their ability to claim their sexual and reproductive rights. The current call solicits proposals for research to be carried out in Bangladesh or Burundi by consortia of at least two research organizations from across the globe, one of which from Bangladesh or Burundi / Great Lakes region. Engagement with practitioner organizations in the relevant focus country is strongly recommended.

#### Special Issue Gender and (Post)Colonialism: Locating Marginalised Voices

Call for papers for the Special Issue Gender and (Post)Colonialism: Locating Marginalised Voices of the Dutch Journal for Gender Studies (<u>Tijdschrift voor Genderstudies</u>), Eds. Maaike Derksen and Margriet Fokken.

The argument made by literary critic and theorist Gayatri Chakravorti Spivak in the 1980s (Spivak 1988), that the recovery of subaltern female voices is virtually impossible has not been without its critics. Different scholars have stated in response to Spivak that a full recovery of the female perspectives might not be possible, but that there is fractured evidence of her voice that offers the possibility for unsettling colonial master narratives (Mani 1998, Joseph 2004, Chaudhuri 2010). This raises questions about how scholars could go about finding marginalised voices and what these voices would add. The *Dutch Journal for Gender Studies* will dedicate a special issue to the subject of locating voices of gendered marginalised 'others', and invites academic articles that reflect on issues of methodology and interpretation involved in researching marginalised voices in colonial and postcolonial contexts.

This special issue will collect contributions reflecting on strategies for retrieving marginalised voices in (post)colonial textual, visual and material sources. We welcome contributions which focus on a (post)colonial context or use (post)colonial sources – not restricted to the Low Countries – and read or engage with (post)colonial archives/sources from a postcolonial feminist perspective. ### Social Class in the 21st century: Intersections between class, gender and sexuality revisited (University of Amsterdam, NL)

Four interconnected developments background our call for a focus on class. First, gender and sexuality are often largely absent from class analysis. Third, the central role that queer approaches to social and cultural analysis attributes to choice, change, and the destabilization of categories comes at a cost, namely the lack of attention to more enduring power relations and inequalities. The way forward, we suggest, is to start unpacking the concept of class. Interestingly, while most of us recognise immediately the notion of class, definitions of it remain elusive and differ tremendously in their reach and implications. During this conference we intend to explore various routes to unpack the formulation of class through the prism of gender and sexuality. We invite papers from the wide

range of social sciences, including social history, to take up these questions and engage in an interdisciplinary debate. Note that we will first organize a call for panels, to be followed by a call for papers.

#### **New Releases**

New Book: The Power of the False (Doro Wiese) Can literature make it possible to represent histories that are otherwise ineffable? In The Power of the False (Northwestern University Press, 2014), named after Gilles Deleuze's concept, <u>Dr. Doro Wiese</u> offers readings of three novels that deal with the Shoah, with colonialism, and with racialised identities.

Wiese argues that Jonathan Safran Foer's *Everything Is Illuminated*, Richard Flanagan's *Gould's Book of Fish*, and Richard Powers's *The Time of Our Singing* are novels in which a space for unvoiced, silent, or silenced difference is created. Seen through the lens of Deleuze and his collaborators' philosophy, literature is a means for mediating knowledge and affects about historical events. Going beyond any simple dichotomy between true and untrue accounts of what 'really' happened in the past, literature's powers of the false incite readers to long for a narrative space in which painful or shameful stories can be included.

"The Powers of the False is undeniably brilliant, rich in its suggestiveness, fertile in its theoretical apparatus, perspicuous in the readings of the three novels it offers in support of its central Deleuzian hypothesis: namely, that in literary writing in our time, there is utilised a kind 'falsity' or 'falseness' which, going beyond the distinction between truth and fiction, summon or call up a virtual audience comprised of the descendants of all of those persons and things of the past who have been ignored, oppressed, or simply eliminated (as in the Holocaust) without benefit even of the registration of their existence." – Hayden White.

Doro Wiese is a lecturer in gender studies and comparative literature at Utrecht University. She was a Marie Curie Early Stage Researcher in the EU FP6 PhD programme GenderGraduates and graduated cum laude in 2011 at Utrecht University.
