Assistant Professor of International Communication (Penn State College of Communications, USA)

Calls for Papers

Special Issue on Queer, Trans, and Feminist Responses to Mass Incarceration

Call for papers for a special Issue of *philoSOPHIA: A Journal of Continental Feminism*, edited by Lisa Guenther and Chloë Taylor, on Queer, Trans, and Feminist Responses to Mass Incarceration. Some feminists have endorsed carceral responses to gender violence and sexual violence, calling for more legal regulation, more comprehensive enforcement of current laws, and harsher punishments for offenders. Others have criticized such responses, arguing that the prison industrial complex is itself a form of institutional violence which compounds the harm of interpersonal violence and the structural violence of racism, poverty, sexism, and heterosexism (see, for example, INCITE! Women of Color Against Violence, *From Carceral to Transformative Justice Feminisms, Against Equality*). For this special issue, we invite queer, trans, and feminist responses to mass incarceration that challenge dominant carceral paradigms. We are particularly interested in papers that engage with the work of people of colour, activists, and currently- or formerly-incarcerated people. Send a 500-word abstract [by email](#).

Conference Sade Today (University of Amsterdam, NL)

Call for papers for the conference *Sade Today*, which will take place on December 2-3 in Amsterdam (NL). Invited speakers are Prof. William Edmiston (University of South Carolina, Columbia), Dr. Rico Sneller (Leiden University, The Netherlands), Prof. Éric Marty (Université Paris VII, France) and Dr. Judith Vega (University of Groningen, The Netherlands).

200 years ago – on Dec. 2, 1814 –, the libertine novelist Marquis de Sade died in an asylum. During that era in history, many ideas on sexuality have been formulated that still influence modern society: the gender dichotomy, sexuality as a natural and private issue, infantine innocence, explicit sexual imagery being taboo, the nuclear family as cornerstone of society, etc. Sade transgressed these beliefs in his work, and opposed such ideas that have become ingrained in Western societies. He made sexuality explicit in his work, put sodomy above coital sex, plural loves above monogamy, incest above marriage and family, spoiling sperm above sparing it, gender diversity above binary discipline, and instead of opposing reason to emotion, he gave them equal value. However, up until now, little attention has been paid to the relation between Sade's transgressive ideas and contemporary views of sexuality that got their shape during the Enlightenment. A thorough investigation of this relation and of the actuality of Sade's work is the general aim of the two-day

conference in Amsterdam.

Researchers from various areas (sociology, philosophy, critical studies, political and historical sciences, etc.) are invited to submit abstracts (300 words) for presentations of 30 minutes to [Dr. Gert Hekma](#) (University of Amsterdam) and [Dr. Lode Lauwaert](#) (University of Louvain)

4th International Conference on the Future of Monogamy and Nonmonogamy (Berkeley, USA)

This is a call for papers for *the 4th International Conference on the Future of Monogamy and Nonmonogamy*, which happens February 13-14, 2015, in Berkeley, California (USA).

This event will be devoted to presentations of scientific and academic research related to polyamory, open relationships, swinging, other forms of consensual nonmonogamy, and related subjects. Presentations will cover various topics that offer some possible progress to a deeper and more complete understanding of the phenomenon of consensual nonmonogamy. Issues related to both nonmonogamous and monogamous relationships will be explored from an interdisciplinary perspective, in as objective and unbiased a manner as possible.

Any presentation that discusses the prevalence of monogamy or nonmonogamy at any particular place, time, or society, or which offers some potential insight into the changing nature of such attitudes and practices over time will be considered. Strong preference is given for presentations with obvious direct relevance to issues related to possible future changes in attitudes about monogamy and nonmonogamy.

We strive to make this a strongly interdisciplinary conference. Presentations can include research related to psychology, sociology, neuroscience, sociocultural studies, anthropology, political science, historical studies, future projections, media studies, examinations of art, folklore and mythology, or any other area of scholarship related to the subject of consensual nonmonogamy.

Preference is for completed projects, but works in progress will also be welcome. Emphasis is on original work not published or previously presented, but exceptions may be made for material deemed especially relevant to the theme of the event. Papers and projects from graduate and undergraduate students will also be welcome.

Papers will be published after the conference in online proceedings with a confirmed ISBN number/reference. There will be no length limit for submissions, but the presentations will be limited to 30 minutes, with ten minutes dedicated to questions, answers, and discussion following each presentation. Proposed presenters are encouraged to send inquires as early as possible.

Performance Research Volume 20, Issue 4 - On Institutions

This is a call for papers for *Performance Research Volume 20, Issue 4 - On Institutions*, edited by Gigi Argyropoulou and Hypatia Vourloumis. The aim of this issue is to explore the relation between performance and institutions building on the premise that institutional structures are formed through repeated sets of practices, patterns and relations. Through a performance studies lens that approaches the figure of the institution as verb, the editorial thinking behind this issue considers how institutions are performance and in turn how performance practices may enforce or destabilise institutions and initiate new modes of organisation. Although often read as abstractions of seemingly objective, entrenched and systematic structures, institutions, whether formal or informal, are always social processes. Thus, if institutional constructions and resources are established through repeated modes of action and arrangements, how might certain performance practices constitute radical acts, becomings and socialities, and by extension, potential performances of instituting otherwise? The aim of this issue is to bring to the fore theoretical discourses and artistic production that explicitly

negotiate with institutions through experimental praxes from within, through and beyond them. This issue seeks to bring together diverse approaches and methodologies of institutional critique past and present as well as propositions for new forms and alternative practices. The editors anticipate the inclusion of both articles and artists' pages. We strongly encourage theoretical examinations, artists' writings, analyses of performances, written exchanges and proposals from various fields.

Workshop *Science Shaping the World of Tomorrow: Scientific Imagination and Development of Society* (University of Antwerp, BE)

Call for Papers for an international academic workshop on *Science Shaping the World of Tomorrow. Scientific Imagination and Development of Society* at the University of Antwerp, Belgium. The workshop is organized by UCSIA and will take place on March 18-20, 2015.

We understand imagination in relation to the scientific context as the art to creatively design, produce, discuss and envisage societal alternatives for the future. In that sense it opens a window on the future and constitutes a source for societal development. Placed within a broader context, imagination processes play a role in the development of sciences and in the construction of societies, as well as in the interaction between sciences and societies, the former stimulating the further development of the latter, and the latter providing an environment in which the former thrives. Sciences and societies shape and further one another's imagination processes.

The study of the creative and productive use of imagination at the intersection of science and society in view of building and shaping the future constitutes the main purpose of this workshop. This reflection will be stimulated by focusing on four subthemes:

1. Imagination at work in the sciences
2. Sciences as part of the imaginary of societies
3. Imaginaries of the future shaping contemporary reality
4. Politics of imagination

The workshop consists of a two-day international meeting with specialized lectures and presentations and debates by invited senior and junior scholars. It provides a forum of exchange of research from different disciplines such as philosophy, history, literature and the arts, sociology, economics, physics, science and technology studies, political sciences, policy studies, etc. Researchers, doctoral students and other experts are welcome to submit their application.

The selected participant will present her/his paper in a panel session (20 minutes in English) and will afterwards send in an article to be considered for publication (which will be submitted to careful selection). The aim of the organizer is to publish a selection of articles presented at the workshop.

The organizer takes on charge all costs pertaining to participation and stay in Antwerp of all selected participants, while travel arrangements and costs are incumbent on participants themselves.

***Transformations* Issue 26 Thinking in the Arts-Science Nexus**

Transformations is calling for submissions for *Issue 26: Thinking in the Arts-Science Nexus*. The arts and the sciences have a complex history of both conflict and entanglement; while disciplinary fiefdoms and the strictures of grant funding bodies have often sought their separation, the immensely fruitful exchange currently happening in the space where art meets science suggests other possibilities. The art-science nexus has been revitalised by new thinking in neurobiology, biotechnology as well as quantum physics, sweeping away mechanistic ideas of isolated subject-object encounters, and replacing them with force fields, immanence, affect and becoming. New methodologies and ways of knowing emerge as scientific objects and processes inform, and are informed by, aesthetic and cultural realms. This issue of *Transformations* seeks submissions that address this growing interest in the art-science nexus and the new knowledges and forms that arise from this connection. Possible topics include:

- Critique and/or method in the arts and sciences,
- Life and art in the new biosciences,
- The appropriation of biosciences in the humanities,

- The virtual as a concept in the sciences and the arts,
- Particular case studies of creative work (artists, writers, poets, film makers etc.) that reflect on or appropriate science,
- Creative practice as a mode of critical intervention in the biosciences,
- Media representations of developments in the biosciences,
- New methods and processes in art/science interaction,
- First-hand accounts of art/science collaboration,
- Aesthetics of biocybernetic design,
- Historical perspectives on the art-science nexus in philosophy and critical thought,
- Non-western perspectives on Western science discourse,
- Philosophy of science,
- Nature philosophy

Special Issue *Sexuality in Movement: Beyond the 'Sexual Revolution'*

Call for papers for the Special Issue "Sexuality in Movement: Beyond the 'Sexual Revolution'" of the *Dutch Journal for Gender Studies*. Editors are Jantine Oldersma and Robert Davidson. This special issue will focus on movements – not restricted to the Low Countries – preoccupied with issues of sexuality defined broadly. This themed issue will provide a platform for contributions on 'movements' in a broader sense that have engaged with sexuality, both with 'progressive' or 'conservative' inclinations. The *Dutch Journal for Gender Studies* welcomes abstracts and manuscripts on 'Sexuality in Movement', potentially including – but not limited to – the following aspects:

- Organizational aspects: How are organizations and groups formed? What is the role of the internet and new media? What is the influence of (collective) identity on group formation? How does the psychology of leaders play a role in an organization and its advocacy? How has an organization survived and evolved over time, or not? What strategies of dramaturgy are enacted in acts of protest, manifestation, and occupation?
- Goal-oriented aspects: What kinds of goals are strived for by activists? Which discourses are challenged by movement organizations? How do organizations frame their arguments and those of opponents? How and in what ways are organizations successful in shifting discourses? Which successes have specific organizations achieved, and through which means? When have organizations failed to reach their goals, and what are potential explanations for those failures?
- Institutional aspects: Which organizations were able to gain access to (governmental) institutions? In which ways were organizations institutionalized? In which ways were movement groups able to exert policy influence? Were particular 'insiders' sympathetic to an organization's cause? In what ways did movement groups simultaneously function as 'insiders' and 'outsiders'?

New Releases

Book Everyday Feminist Research Praxis: Doing Gender in the Netherlands

Everyday Feminist Research Praxis: Doing Gender in The Netherlands offers a selection of previously unpublished work presented during the annual Research Days of the Netherlands Research School of Gender Studies (NOG) in 2011, 2012 and 2013. Reflecting the wide spectrum of interdisciplinary gender studies, this volume is organised into four sections along four conceptual knots. These thematic entry-points are space/time, affectivity, public/private, and technological mediation. The central emphasis of this volume is twofold: first, the everyday is approached as a concretely grounded site of micro-political power struggles. Second, the contributors make explicit connections between theory and their everyday feminist research practices. As a whole, the interventions – ranging from fashion modelling, child-birthing discourses and digital documentaries – show how feminist research praxis remains crucial in critically disentangling naturalized routines of daily life, which in turn enables the scrutiny of, for example, the arbitrariness of entrenched power relations and contradictory, personal and collective, everyday trajectories. *Everyday Feminist Research Praxis*, thus, energises possibilities for new forms of recognition, representation and redistribution of power.
