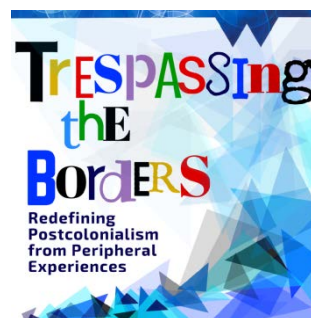

article "The Tactics of Menstruation in Dutch Cases of Sexual and Infanticide, 1750-1920" by Dr Willemijn Ruberg (Cultural Utrecht University, NL) has been chosen as the runner-up for the *of Women's History* best article bi-annual prize for 2013-2014. prize committee evaluated each article published during this two-cycle, with an eye toward finding the article that "makes a significant contribution to the international field of women's by incorporating a comparative dimension, considering contexts its main geographical and temporal focus, employing methodologies that demonstrate historical interconnections across time and space, and/or advancing feminist theories in women's history". The prize will be formally announced at the 2017 upcoming Seventeenth Berkshire Conference on the History of Women at Hofstra University, New York, June 1-4, 2017.
